

END-USER SOFTWARE LICENSE AGREEMENT FOR NEOVALIS WEBDAV CLIENT

IMPORTANT NOTICE - READ CAREFULLY BEFORE INSTALLING AND USING THIS SOFTWARE.

NEOVALIS WebDAV is a computer-software protected under the laws of the Republic of Austria.

This Neovalis End-User Software License Agreement ("EULA") is a legal agreement between you ("LICENSEE"), and Neovalis IT Development GmbH ("NEOVALIS"). For the purposes of this EULA, the NEOVALIS WebDAV Client ("PRODUCT") includes computer software and may include associated media, printed materials, online or electronic documentation, and Internet-based services and all other files contained in the installation file you received.

By installing, copying or otherwise using the PRODUCT you agree to be bound by the terms of this EULA. If you do not agree, do not install, copy or use the PRODUCT in any way and promptly remove any copies, electronic or otherwise, that have been made.

1. LICENSE GRANT

Subject to a respective License Purchase Agreement to be concluded separately between NEOVALIS and LICENSEE latter is granted the following rights under this EULA:

1.1. INDIVIDUAL DEVELOPER LICENSES

NEOVALIS grants LICENSEE the right to use one copy of the PRODUCT, or any prior version legally licensed for the same operating system, for the sole purpose of the development of software applications.

Each person working with or otherwise using the PRODUCT for LICENSEE, may he be an employee of LICENSEE or not, must have his own licensed copy of the PRODUCT, regardless whether he directly uses the component or not. The sale of individual developer licenses is considered final.

1.2. SITE LICENSES

NEOVALIS grants LICENSEE the right to use the PRODUCT, or any prior version legally licensed for the same operating system, on any and all computers located at a single physical site for the sole purpose of the development of software applications. The sale of site licenses is considered final.

1.3. SOURCE CODE LICENSE

NEOVALIS grants LICENSEE the right to internally use or modify the source code of the PRODUCT at LICENSEE's site for the purposes of developing, designing and testing a software application, provided that such software application does not directly compete with NEOVALIS products. A message displaying "Contains software licensed from Neovalis." and the URL "www.neovalis.com" must be shown in the About screen of any application developed by using or containing NEOVALIS source code.

Individual Developer or Site- Licenses are required for a source code license to be valid. The sale of source licenses is considered final.

1.4. EVALUATION LICENSE

NEOVALIS may provide an evaluation version of the PRODUCT. By using an evaluation version of the PRODUCT, LICENSEE is granted a License for a period of fifteen (15) days after installation of the evaluation version of the PRODUCT ("Evaluation Period"). After the Evaluation Period, LICENSEE shall either (i) delete the PRODUCT and all related documentation from ALL computers or storage devices, onto which it was installed or copied, or (ii) purchase the PRODUCT from NEOVALIS or one of its authorized distributors. LICENSEE may use the evaluation version of the PRODUCT for evaluation purposes only and may not distribute in any form or manner ANY of the files provided with the evaluation version of the PRODUCT, as well as ANY software applications developed, designed or tested with the PRODUCT during the Evaluation Period, to ANY PARTIES.

1.5. COMMUNITY EDITION

NEOVALIS may provide a community edition of the PRODUCT. The features of the community edition of the PRODUCT are restricted as set forth in the current product feature list. You acknowledge that these restrictions are subject to amendment by NEOVALIS at any time without notice, on sole discretion of NEOVALIS.

2. RIGHTS AND LIMITATIONS

2.1 "NOT FOR RESALE SOFTWARE"

PRODUCT identified as "Not For Resale" or "NFR" or any derivative work created using the PRODUCT may not be resold, distributed or otherwise transferred for value or benefit in any manner by LICENSEE, notwithstanding other sections of this EULA. This also applies to any and all intermediate files, source code, and compiled executables of the PRODUCT.

2.2. LIMITATION ON REVERSE ENGINEERING, DECOMPILATION, AND DISASSEMBLY

LICENSEE may not reverse engineer, decompile, create derivative works, modify, translate, or disassemble the PRODUCT, except and only to the extent that such activity is expressly

permitted by applicable law notwithstanding this limitation. LICENSEE agrees to take all reasonable, legal and appropriate measures to prohibit the illegal dissemination of the PRODUCT or any of its constituent parts and redistributables to the fullest extent of all applicable Local and International Laws and Treaties regarding anti-circumvention.

2.3. RENTAL

LICENSEE may not rent, lease, or lend the PRODUCT.

2.4. REDISTRIBUTABLES

PRODUCT may include certain files ("Redistributables") intended for distribution by LICENSEE to the users of software applications created by LICENSEE. Redistributables include, for example, files identified in printed or on-line documentation as redistributable files, or files preselected for deployment by an install utility provided with the PRODUCT (if any). In any event, the redistributables for the PRODUCT are only those files specifically designated as such by NEOVALIS. Subject to terms and conditions of this EULA, LICENSEE may reproduce and distribute exact copies of the redistributables, provided that such copies are made from the original copy of the PRODUCT or the copy transferred to a single hard disk. Copies of redistributables may only be distributed with and for the sole purpose of executing application programs permitted under this EULA that you have created using the PRODUCT. Under no circumstances may any copies of redistributables be distributed separately.

The following file(s) are considered redistributables under this EULA:

Neovalis.WebDAV.Client.dll

LICENSEE is not authorized to distribute any other file contained in the PRODUCT .

While using an EVALUATION VERSION of the PRODUCT, LICENSEE is prohibited from distributing any of the files contained in the PRODUCT .

While using the COMMUNITY EDITION of the PRODUCT, LICENSEE is allowed to redistribute the redistributable files under the condition that:

- a) LICENSEE clearly indicates in the derived work that it contains software licensed from NEOVALIS, including contact information (Street Address and Web Site), and
- b) LICENSEE distributes the derived work as an open source project and adheres to the redistribution restrictions laid down in this EULA.

3. RESERVATION OF RIGHTS AND OWNERSHIP

The PRODUCT, its source code and all associated files are property of NEOVALIS and are protected by copyright and other intellectual property laws and treaties. NEOVALIS or its subsidiaries own the title, copyright, and other intellectual property rights in and to the PRODUCT (including but not limited to any images, demos, source code, intermediate files, packages, photographs, redistributables, animations, video, audio, music, text, and "applets" incorporated into the PRODUCT the accompanying printed materials, and any copies of the

PRODUCT). The PRODUCT is licensed, not sold.

LICENSEE may install the PRODUCT on a single computer and keep the original solely for backup or archival purposes. LICENSEE shall not copy the printed materials accompanying the PRODUCT.

The PRODUCT is licensed as a single PRODUCT. The provision of source code, if included with the PRODUCT, does not constitute transfer of any legal rights to such code, and resale or distribution of all or any portion of all source code and intellectual property will be prosecuted to the fullest extent of all applicable local, federal and international laws. All NEOVALIS libraries, source code, redistributables and other files remain NEOVALIS' exclusive property. You may not distribute any files, except those that NEOVALIS has expressly designated as redistributable.

In case the PRODUCT is purchased or used with any intent to reverse engineer, decompile, create derivative works, exploit or unauthorizedly transfer any of NEOVALIS intellectual property and trade secrets, including any exposed methods or source code (where provided), no license shall be granted and any use of the PRODUCT shall constitute an infringement of NEOVALIS' intellectual property rights. Any sale or resale of intellectual property or created derivatives so obtained will be prosecuted to the fullest extent of all local, and international law.

4. ADDITIONAL RESTRICTIONS

Distribution by LICENSEE of any design-time tools (EXE's or DLL's), executables, and source code distributed to LICENSEE by NEOVALIS as part of this PRODUCT and not explicitly identified as a redistributable file is strictly prohibited. Redistribution by LICENSEE's users of NEOVALIS' DLL's or of a LICENSEE-modified version of NEOVALIS redistributable files without an appropriate redistribution license obtained from NEOVALIS is strictly prohibited.

LICENSEE shall not develop software applications that provide an application programming interface to the PRODUCT or the PRODUCT as modified.

LICENSEE may NOT distribute the PRODUCT, in any format, to third parties for development or application compilation purposes. Specifically, if LICENSEE creates a control using the PRODUCT as a constituent control, LICENSEE may NOT distribute the control created with the PRODUCT (in any format) to third parties to be used at design time or for ANY development purposes.

LICENSEE MAY NOT CREATE ANY TOOL OR PRODUCT THAT DIRECTLY OR INDIRECTLY COMPETES WITH THE PRODUCT, WHICH UTILIZES ALL OR ANY COMPONENT OF THE PRODUCT.

5. PRODUCT TRANSFER

LICENSEE may NOT permanently or temporarily transfer ANY of his rights under this EULA to any third party. Regardless of any modifications made by LICENSEE and regardless of the way LICENSEE might compile, link, and/or package his programs, under no circumstances may the

libraries, redistributables, and/or other files of the PRODUCT (including any components thereof) be used for software application development by any third parties. Only LICENSEE has the right to use the libraries, redistributables, or other files of the PRODUCT (or any components thereof) for the development of software applications created with the PRODUCT. In particular, LICENSEE may not share copies of the redistributables with other co-developers. LICENSEE may not reproduce or distribute any NEOVALIS documentation without explicit permission by NEOVALIS.

6. TERMINATION

Without prejudice to any other rights or remedies, this Agreement becomes subject to termination by NEOVALIS upon LICENSEE's failure to comply with the terms and conditions of this EULA. In such case LICENSEE shall immediately cease ANY and ALL use of the PRODUCT technology, remove such technology from any applications developed by LICENSEE by using technology contained in the PRODUCT, whether in native, altered or compiled state, and shall destroy all copies of the PRODUCT and all of its component parts, including any related documentation.

7. UPGRADES

If the PRODUCT is labelled as an upgrade, LICENSEE needs to be properly licensed to use the PRODUCT identified by NEOVALIS as being eligible for the upgrade in order to use the PRODUCT. A PRODUCT labelled as an upgrade replaces and/or supplements the PRODUCT that formed the basis for your eligibility for the upgrade, while the PRODUCT and the upgrade constitute a single PRODUCT. Any use of the resulting upgraded PRODUCT by LICENSEE is subject to all terms and conditions of this EULA.

8. DUAL MEDIA SOFTWARE

You may receive the PRODUCT in more than one medium. Regardless of the type or size of medium you receive, you may use only one medium that is appropriate for your single computer. You may not use or install the other medium on another computer. You may not loan, sell, rent, lease, or otherwise transfer in any manner the other medium to another user or entity.

9. INSTALLATION AND USE

The license granted in accordance with this EULA is subject to all of the following conditions:

- a) all copies of the programs created by LICENSEE must bear a valid copyright notice, either LICENSEE's own or the NEOVALIS copyright notice that appears on the PRODUCT;
- b) LICENSEE shall not remove or alter any NEOVALIS copyright, trademark or other property rights notice contained in any part of NEOVALIS libraries, source code, Redistributables or other files that bear such notice;

- c) NEOVALIS provides no warranty to any person, so that LICENSEE will remain solely responsible to any third party receiving LICENSEE's software for support, service, upgrades, or technical or other assistance, and such recipients will have no right to demand such services or assistance from NEOVALIS;
- d) LICENSEE shall indemnify and hold NEOVALIS, its affiliated companies and its suppliers harmless from and against any claims or liabilities arising out of the use, reproduction or distribution of LICENSEE's software or from any other services provided by LICENSEE;
- e) LICENSEE's software containing or developed with the use of the PRODUCT by NEOVALIS must be written using a licensed copy of the PRODUCT;
- f) LICENSEE's software must add primary and substantial functionality, and may not be merely a set or subset of any of the libraries, code, Redistributables or other files of the PRODUCT;
- g) LICENSEE may not use NEOVALIS's or any of its affiliated companies' or suppliers' names, logos, or trademarks to market his programs.

10. DISCLAIMER OF WARRANTIES

NEOVALIS EXPRESSLY DISCLAIMS ANY WARRANTY FOR THE PRODUCT. THE PRODUCT AND ANY RELATED DOCUMENTATION IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPLICIT OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT. THE ENTIRE RISK ARISING OUT OF USE OR PERFORMANCE OF THE PRODUCT REMAINS WITH LICENSEE.

11. DISCLAIMER OF DAMAGES

NEOVALIS assumes no liability for damages, direct or consequential, which may result from the use of the PRODUCT, even if NEOVALIS has been advised of the possibility of such damages. To the maximum extent permitted by applicable law, in no event shall NEOVALIS be liable for any special, incidental, indirect, or consequential damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use the PRODUCT or the provision of or failure to provide Support Services, even if NEOVALIS has been advised of the possibility of such damages. NEOVALIS' entire liability and your exclusive remedy shall be, at NEOVALIS' option, either (a) return of the price paid, or (b) repair or replacement of the PRODUCT that does not meet NEOVALIS' Limited Warranty and which is returned to NEOVALIS with a copy of your receipt. DO NOT RETURN ANY PRODUCT (S) UNTIL YOU HAVE CONTACTED THE NEOVALIS CUSTOMER SERVICE DEPARTMENT AND OBTAINED A RETURN AUTHORIZATION NUMBER. This Limited Warranty is void if failure of the PRODUCT has resulted from accident, abuse, or misapplication. Any replacement PRODUCT will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. Outside the United States, neither these remedies nor any PRODUCT (s) support services offered by NEOVALIS are available without proof of purchase from an authorized non-U.S. source. Some states and jurisdictions do not allow the exclusion or limitation of liability, so the above limitation may not apply to you.

12. UNITED STATES GOVERNMENT USERS RESTRICTED RIGHTS

The PRODUCT is provided with RESTRICTED RIGHTS. Use, duplication, or disclosure by the United States Government is subject to restrictions as set forth in subparagraph (c)(1)(ii) of the Rights in Technical Data and Computer SOFTWARE PRODUCT(S) clause at DFARS 252.227-7013 or subparagraphs (c)(1) and (2) of the Commercial Computer SOFTWARE PRODUCT(S) Restricted Rights at 48 CFR 52.227-19, as applicable. Manufacturer is Neovalis IT Development GmbH, Mitisgasse 17/6, 1140 Vienna/Austria.

13. GOVERNING LAW AND DISPUTE RESOLUTION

13.1. DISPUTE RESOLUTION

Any party to this license agreement shall have the right to have recourse to and shall be bound by the Pre-Arbitral Referee Procedure of the International Chamber of Commerce, Paris, in accordance with its Rules for a Pre-Arbitral Referee Procedure.

All disputes arising out of or in connection with the present agreement shall be finally settled under the Rules of Arbitration of the International Chamber of Commerce, Paris, by three arbitrators appointed in accordance with the said Rules of Arbitration.

The Pre-Arbitral Referee Procedure and the Arbitration proceedings shall take place in Vienna, Austria, and the language to be used in the Pre-Arbitral Referee Procedure and the Arbitral proceedings shall be the English language.

13.2. GOVERNING LAW

This license agreement shall be governed by and construed in accordance with the substantive law of the Republic of Austria, to the exclusion of the Austrian Private International Law Act (IPRG) and the exclusion of the UN Convention on Contracts for the International Sale of Goods (CISG).

14. MISCELLANEOUS

14.1. SEVERABILITY

In case one or more of the provisions contained in this Agreement should be or become fully or in part invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions contained in this Agreement shall not in any way be affected or impaired thereby. Provisions which are fully or in part invalid, illegal, or unenforceable shall be replaced by a provision which best meets the purpose of the replaced provision. The same applies in case of any omission in this Agreement.

14.2. AMENDMENTS

This EULA may only be amended and/or modified in writing signed by both parties.

14.3. EXPORT RESTRICTIONS

If this product was acquired outside of Austria, LICENSEE agrees to adhere to all international copy right laws and treaties, including but not limited to export restrictions that your country sets forth.

14.3. UN EMBARGOS

LICENSEE agrees to not ship any derived work based upon PRODUCT to countries that are embargoed by the United Nations.
